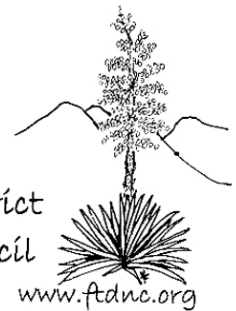

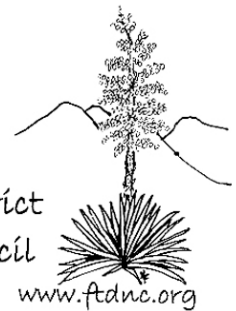
*Equestrian Committee Meets Every 2<sup>nd</sup> Thursday of each Month at 7:30 pm*
