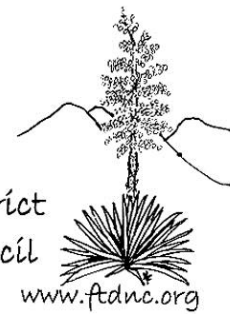

 - c) 9304 and 9310 Hillrose and 9315 Wayside lot line adjustments to create 3 parcels 23,602 sq.ft. to 34,746 sq.ft. DIR 2015-3710PMEX.
