**PUBLIC COMMENT:** Speakers shall limit their comments to matters relevant to the item on the agenda. The amount of time for public comment on each agenda item is to be determined by the Chair at each meeting. The Chair may rule that the speaker is out of order if the comments are not germane to the item under consideration. If multiple requests for public comment are submitted on one agenda item, preference will be granted to members of the public who have not spoken previously during the meeting, either during general public comment or on another agenda item. California Code of Civil Procedure Section 1094.6 governs the time in which a party may seek judicial review of this determination.
